He is fixing up the outside shed for her mom to live in. They have installed security system with cameras so they can see who comes to door, etc. Patrick had accidentally broken the earpiece off Mary's glasses so she only has one side on until they get to eye doctor. The kids seemed ok, just a bit distracted. Mary was distracted with her phone, and Patrick with video games in his room. They were supposed to go to their dad's tonight but Anna told him she wanted them for the weekend. Their other sister was going to stay the night with them. She also told me they are going to take Gary's ex back to court as his son's arm is not healing and his sibling was taken by the father. Since then, he has been having accidents in his underwear, etc. Anna told me she is back on her medications and is less anxious. She seemed calmer than normal.
